2008 NCCU ALUMNI AWARDS

1. **Volunteer of the Year Award** (Giving Back Award):
Criteria: Must provide a minimum of 10 volunteer service hours to an alumni chapter and/or the National Alumni Association; cannot be an elected chapter or national officer; All volunteer hours must be documented; Letter of recommendation must accompany nomination.
DEADLINE FOR ENTRY: May 28, 2010

2. **Young Alumni Award:**
Criteria: Alumnus who joined a chapter within 2 years of graduating from NCCU or an alumnus who falls within the target group identified by the Eagle Outreach Committee and has been involved in chapter or national activities for at least two years; Financial; actively involved in chapter/regional/national events (must list); provide written response to question (limited to 1 page): ***How have you and how will you continue to encourage young alumni to join and actively participate in the NCCU Alumni Association?***
DEADLINE FOR ENTRY: May 28, 2010

3. **Distinguished Alumni Award:** Criteria: Alumnus who has received notable recognition within the community, state, or nation; Documentation of recognition must accompany nomination. Bio must accompany.
DEADLINE FOR ENTRY: June 4, 2010

4. **Chapter of the Year:**
Criteria: Must provide completed package to include, but not limited to: Outline of goals set and the achievement process of each; Creativity (newsletter, banquets, fundraisers, etc); Recruitment initiatives; Number of financial members; List of chapter events or functions (goals and outcomes must be listed). Explain any additional reasons for your nomination.
DEADLINE FOR ENTRY: June 4, 2010

5. **Alumnus of the Year:**
Criteria: Must be financial BOTH LOCAL AND NATIONAL; Exemplifies the heart and soul of the mission of the Alumni Association (explained); Chapter affiliation and notable participation (attendance, committee chair, officer, etc.); Notable achievements (civic, political, cultural, etc.-explain all); Statement of why this individual deserves to be recognized as Alumnus of the Year (1 page or less).
DEADLINE FOR ENTRY: June 4, 2010

6. **Truth & Service:**

Criteria: Individual(s) dedicated to the mission of NCCU; often works behind the scene to accomplish chapter or organizational goals; accepts request for assistance without hesitation; exemplifies the true spirit of Truth and Service (1-2 paragraph explaining).
